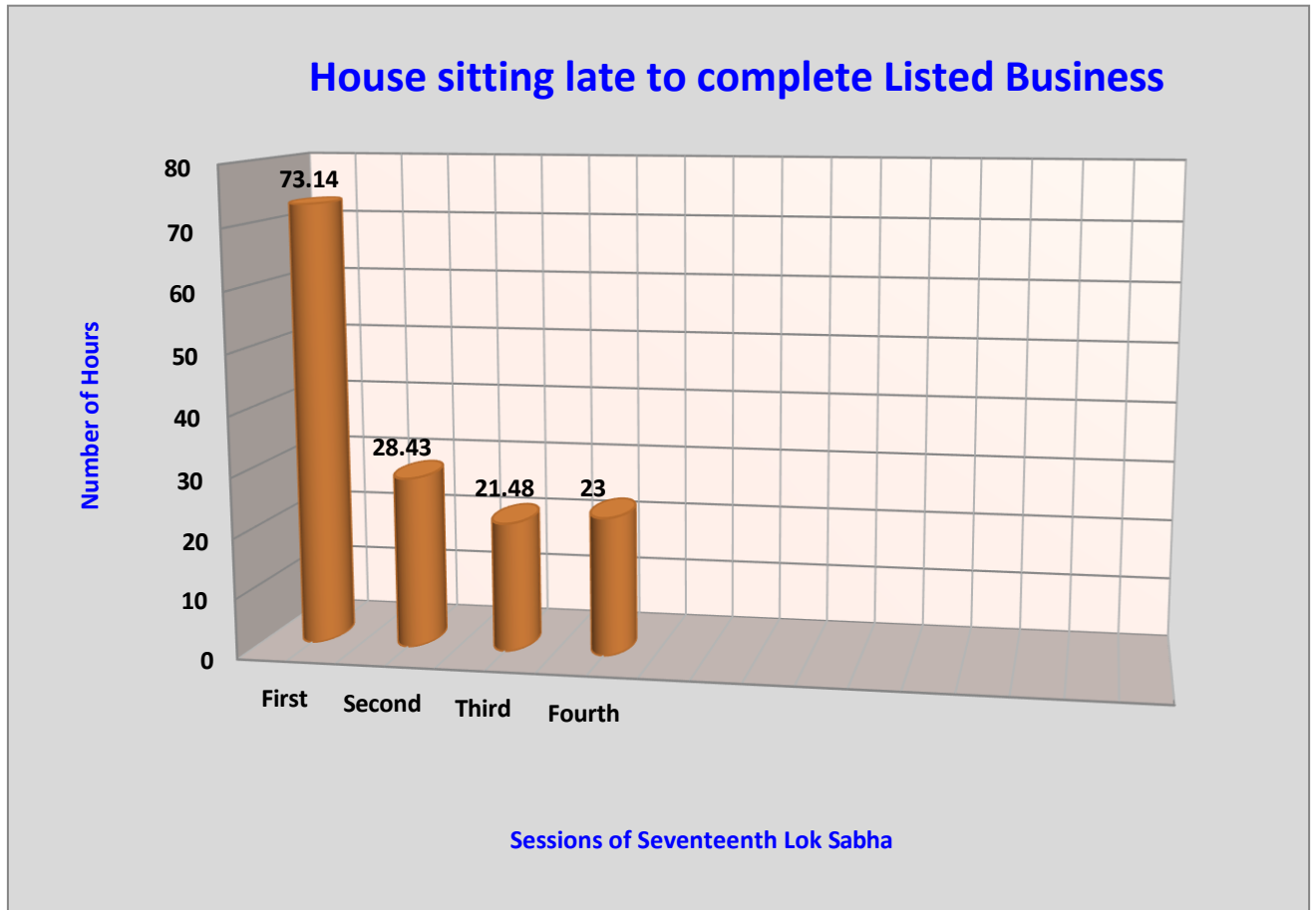


Sitting Hours and Time lost due to interruptions/forced adjournments



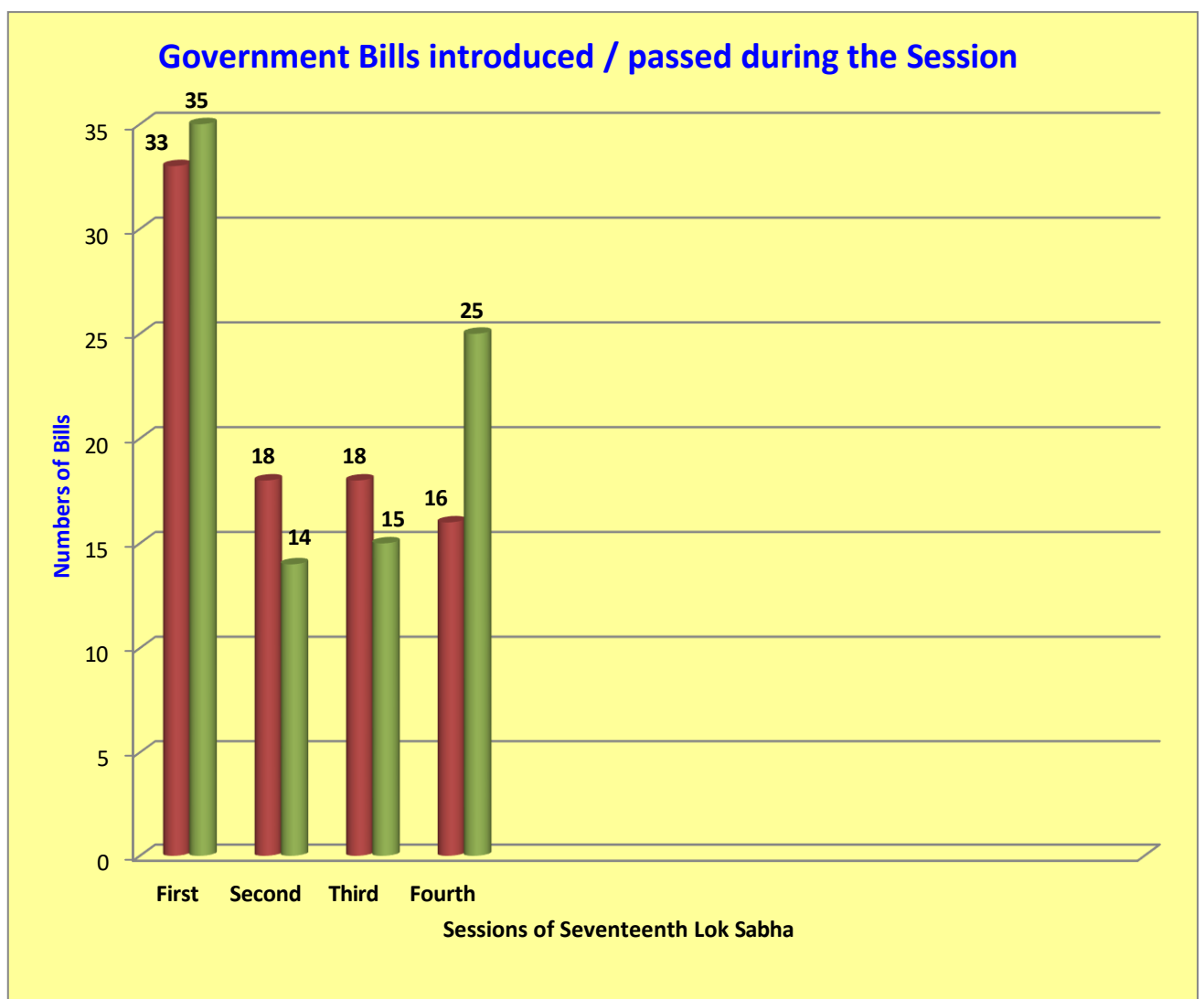

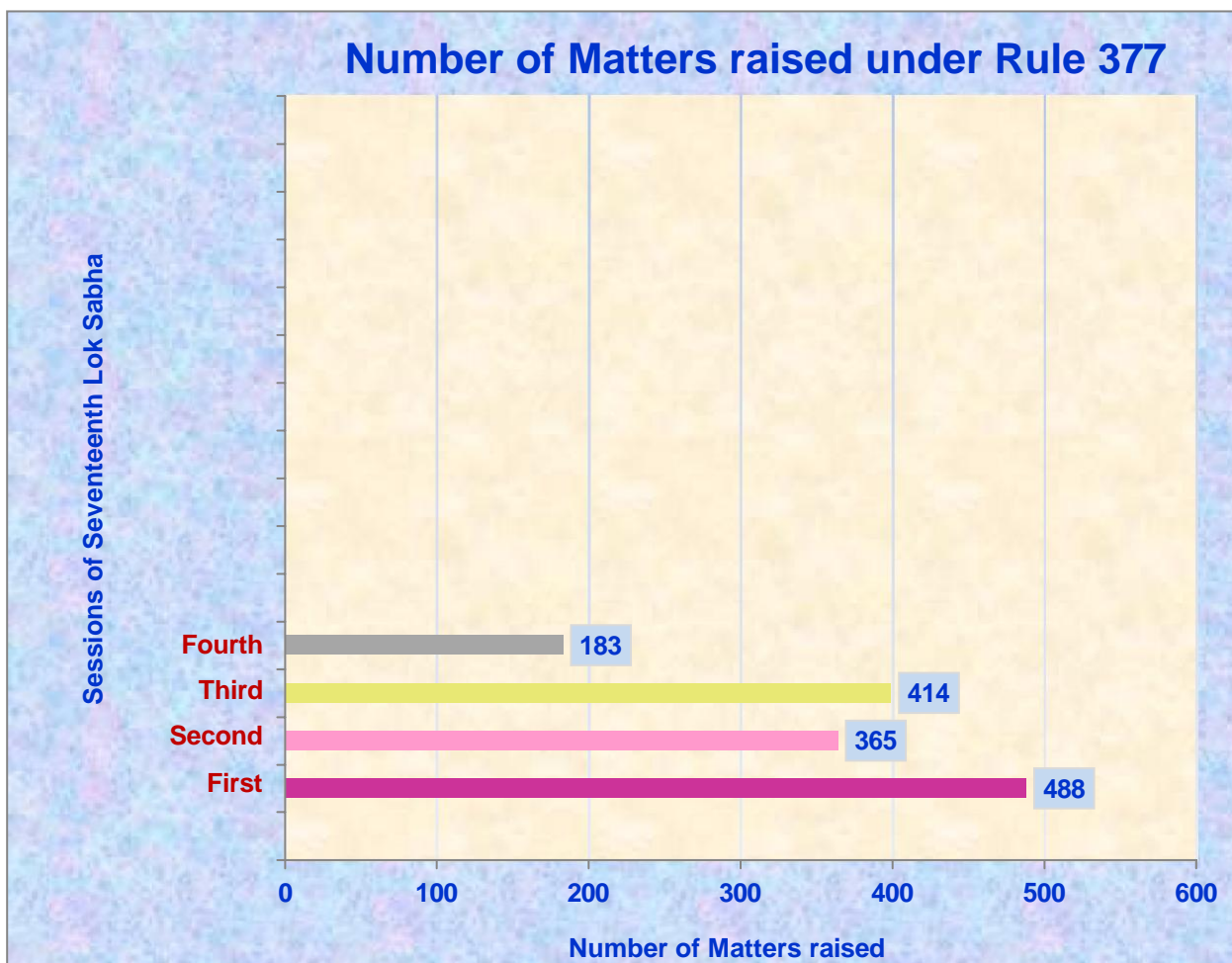

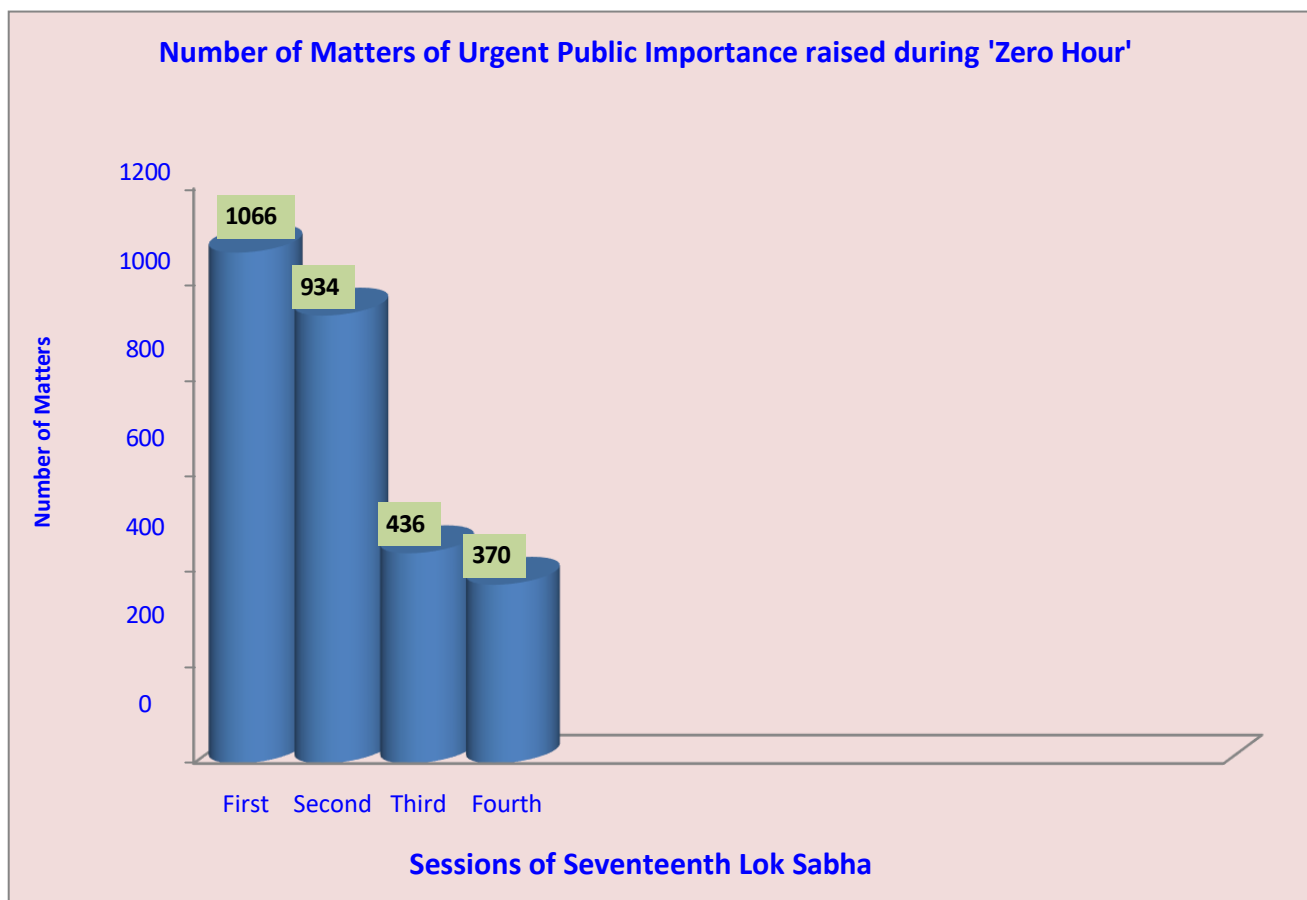
9. Number of matters raised under Rule 377 (Fourth Session) 183

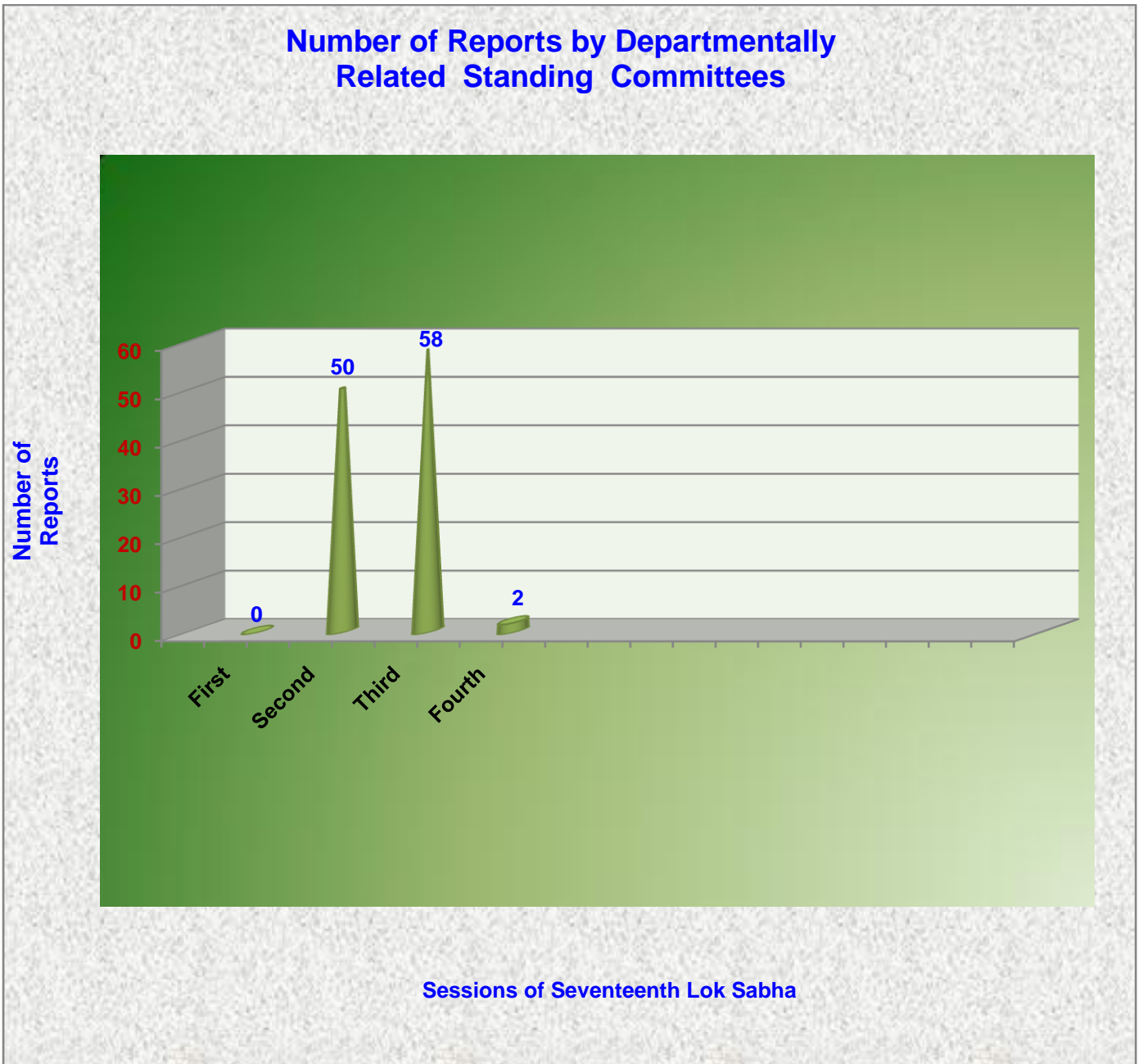

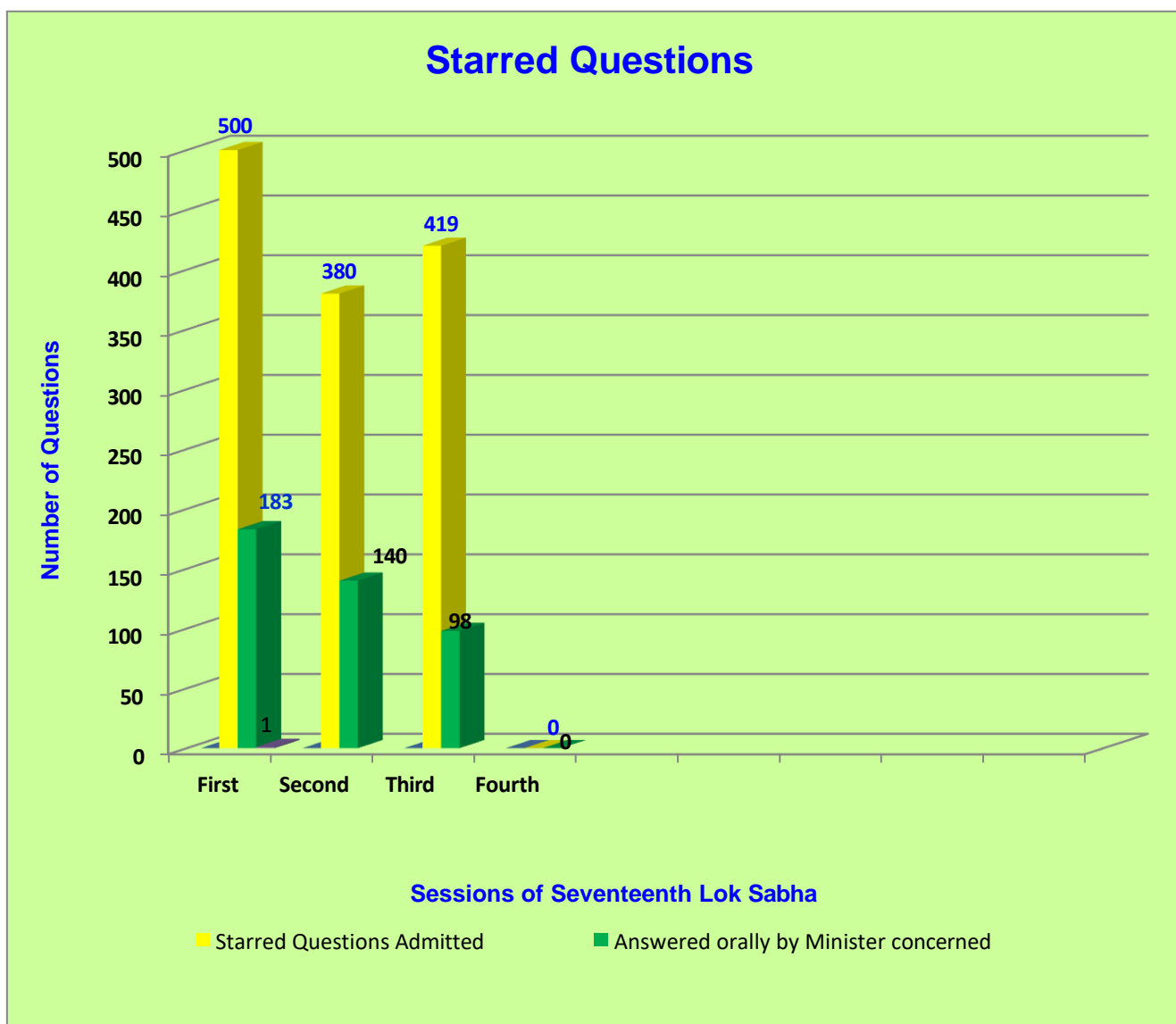

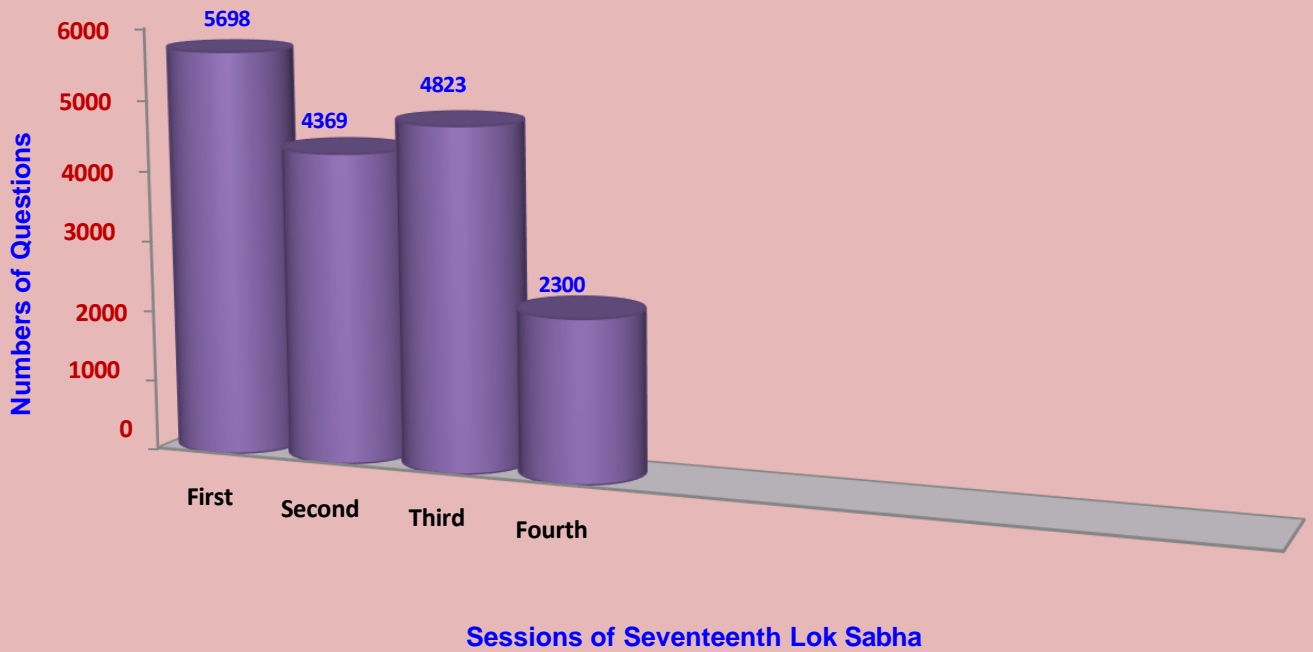
