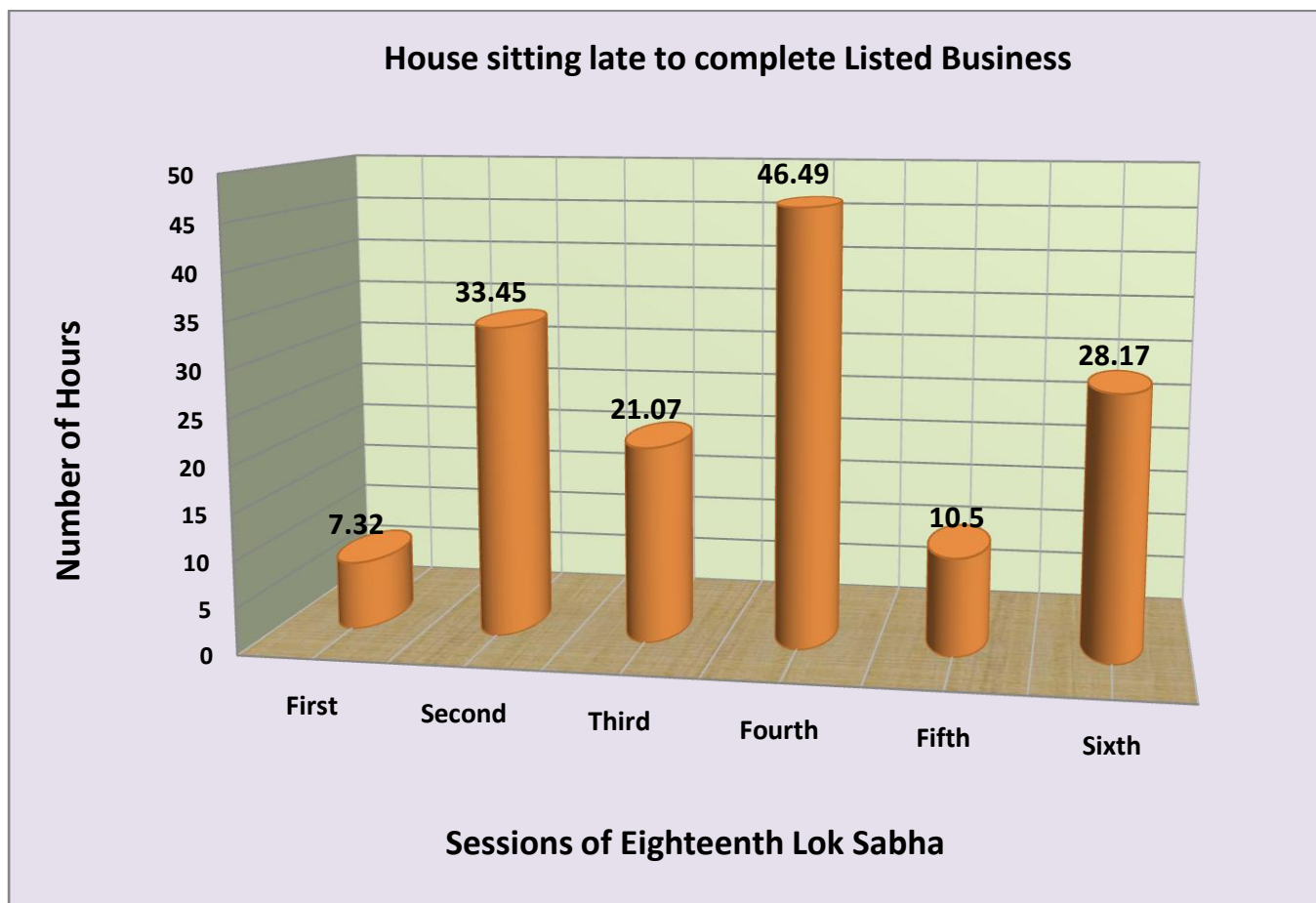


### Sitting Hours and Time lost due to interruptions/forced adjournments

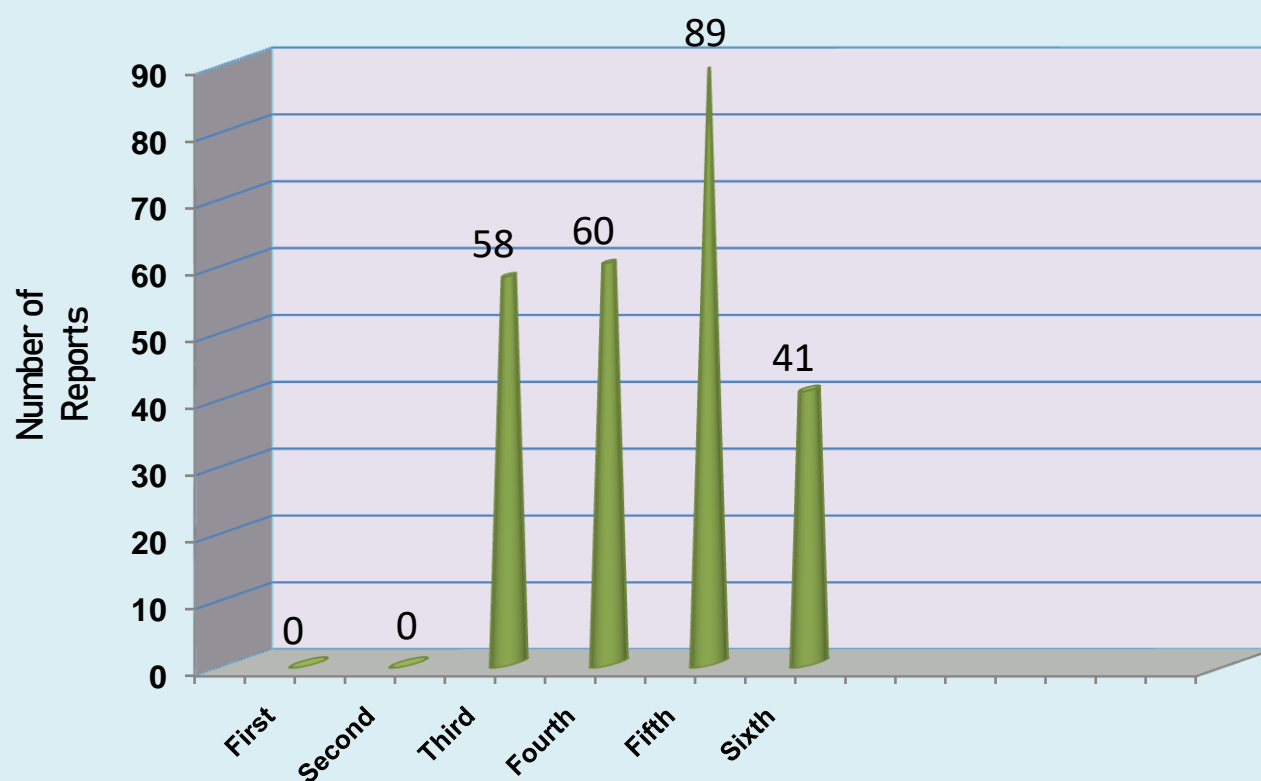

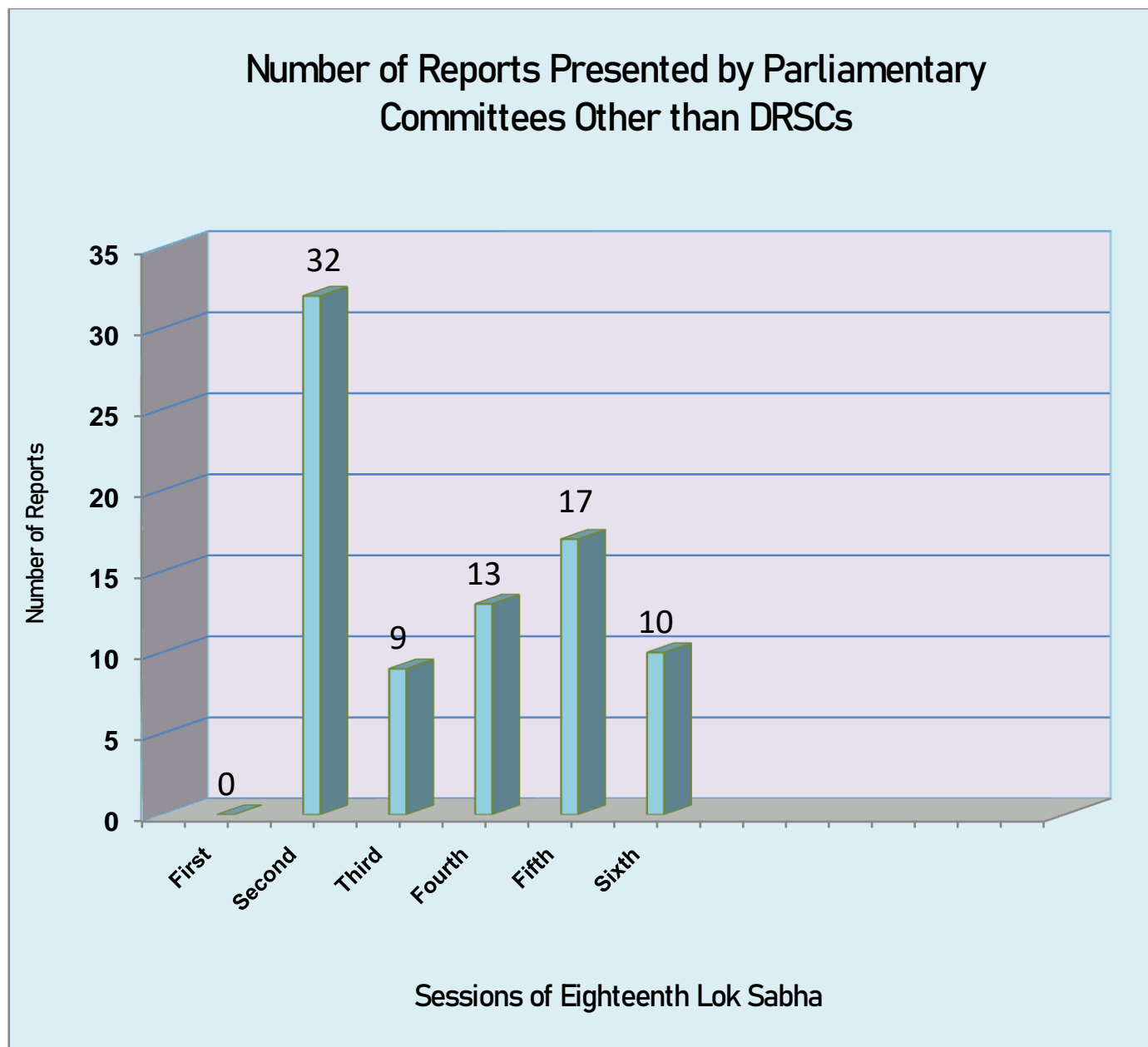
### Number of Reports by Departmentally Related Standing Committees

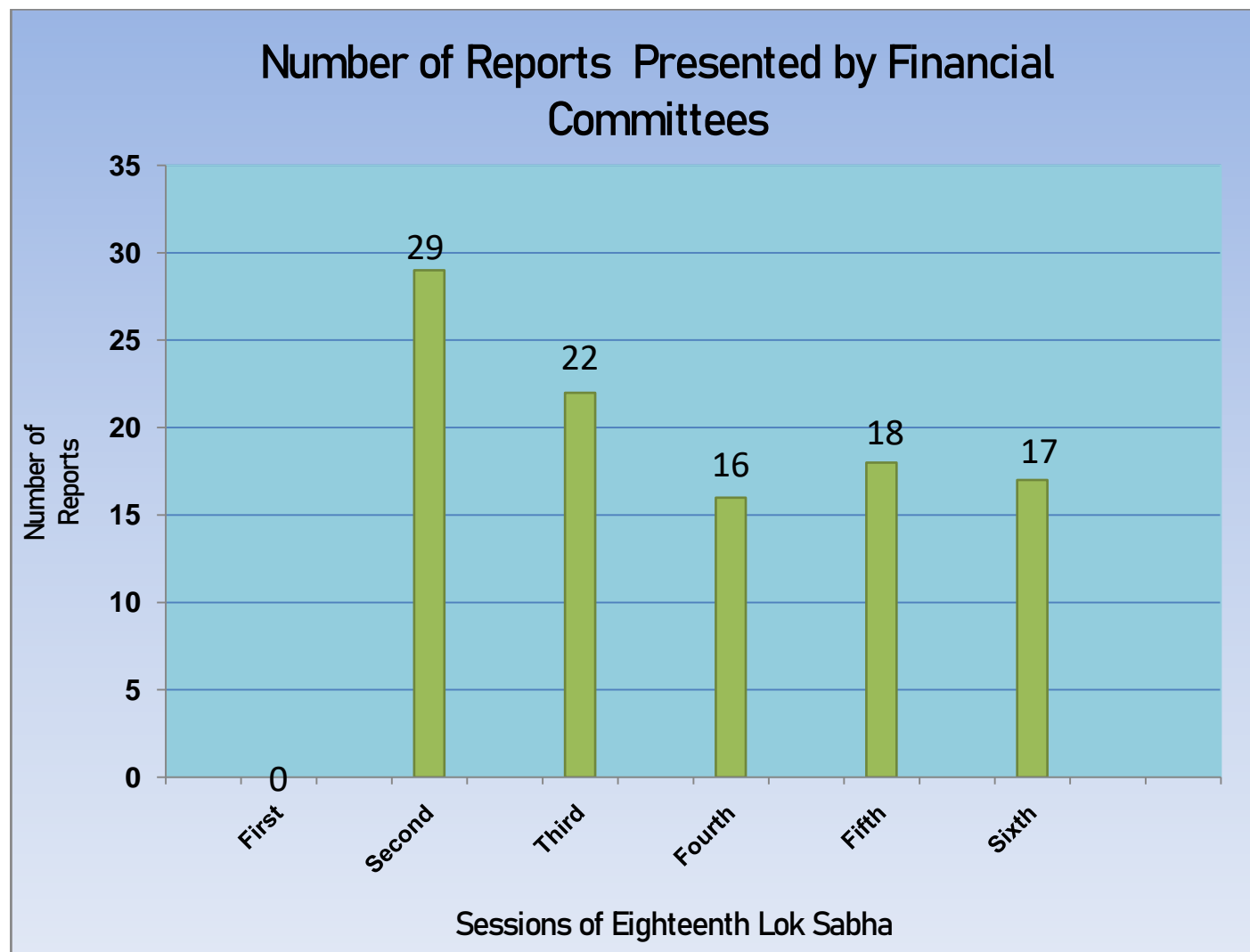

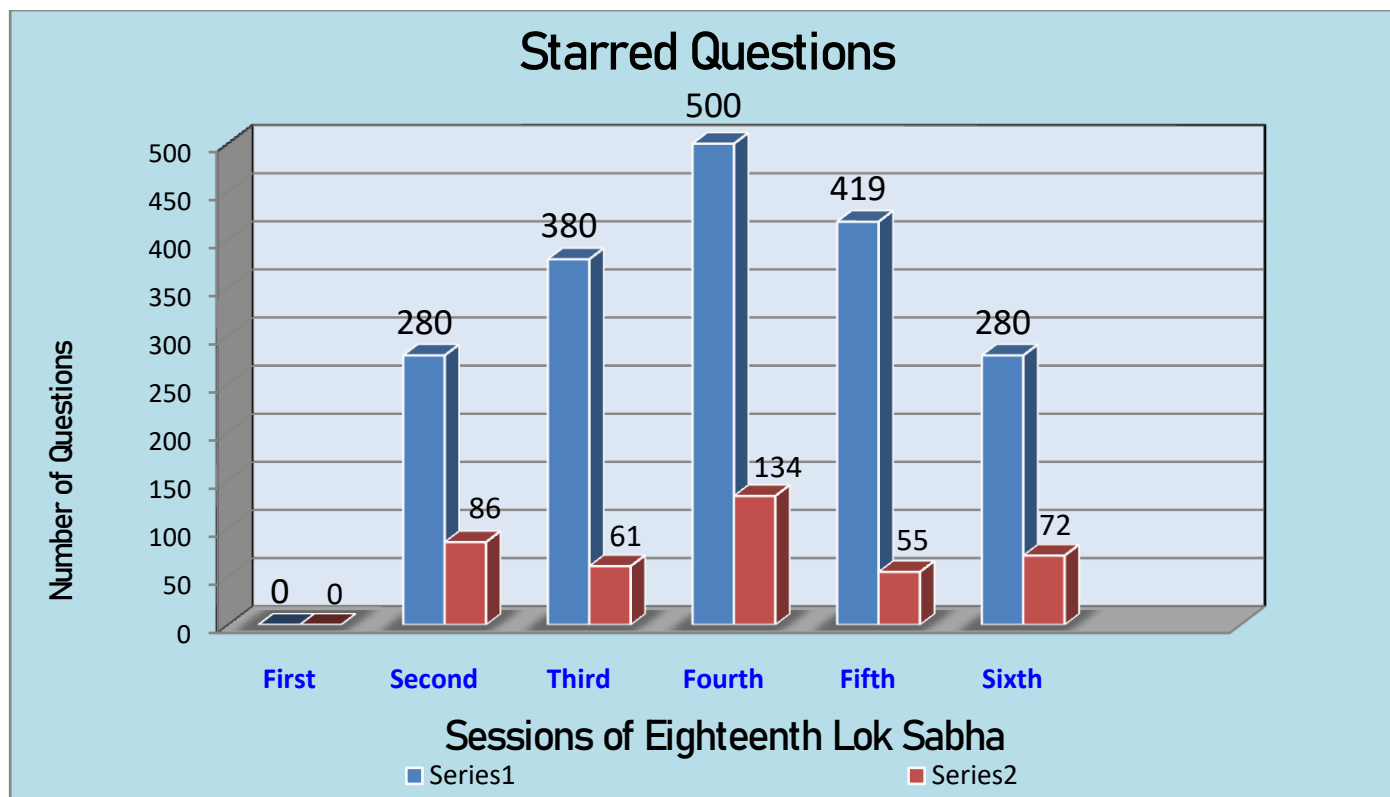

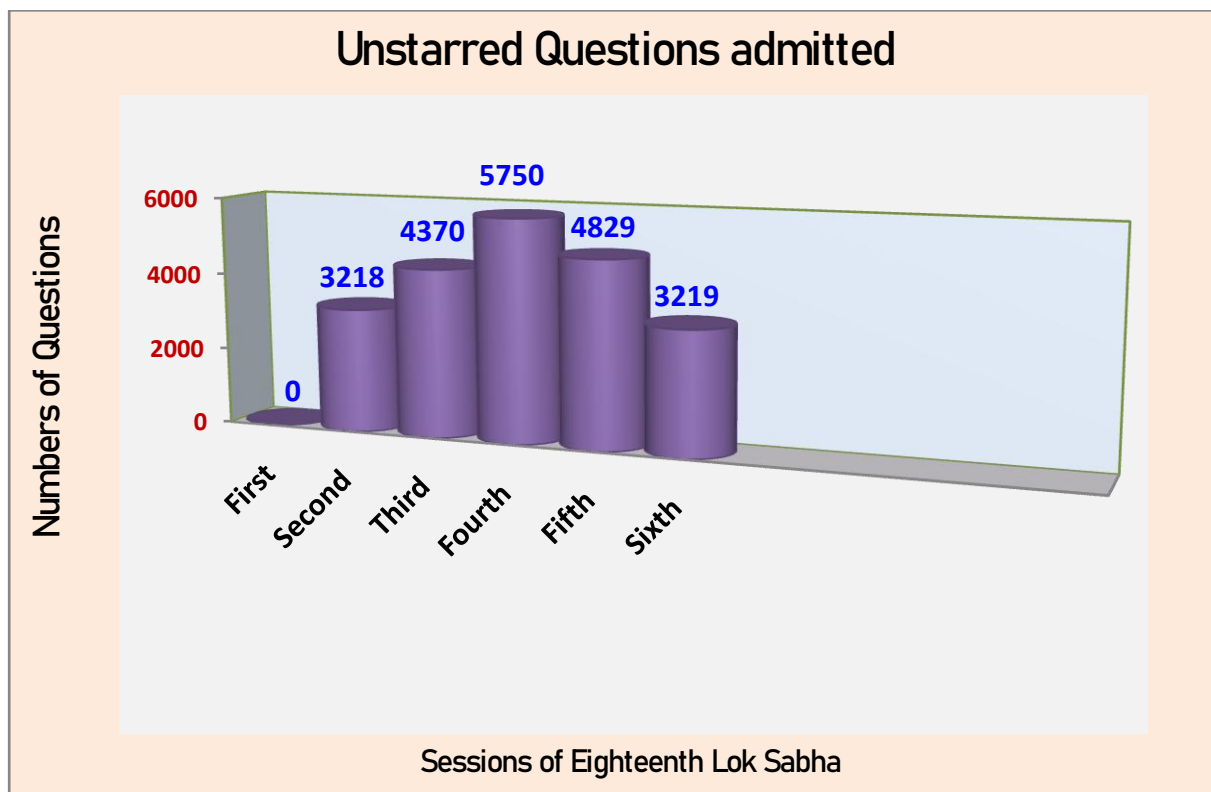
